3. M. LEVIN & ASSOCIATES shall have the right to charge the full rental price on any orders cancelled after the deadline date.

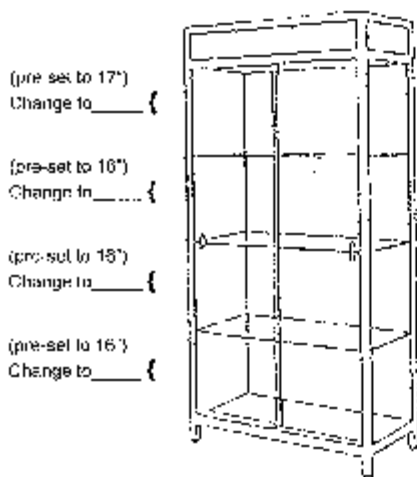

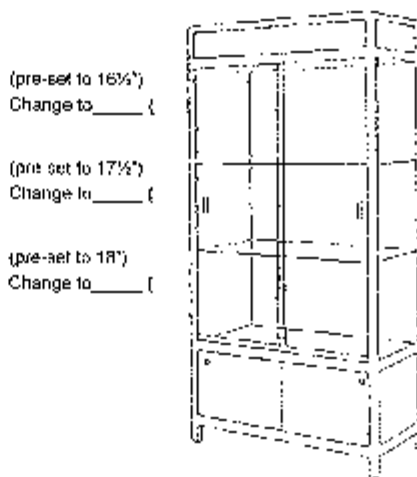
## Shelf Placement

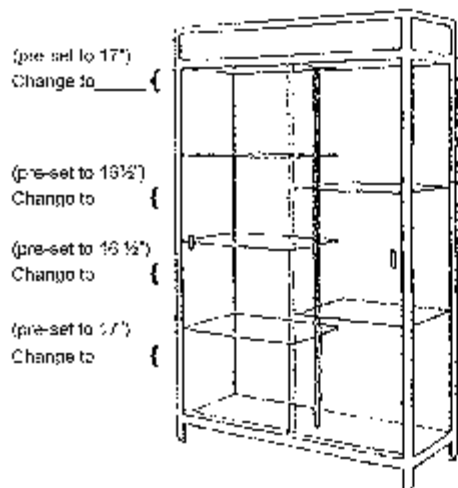

(interior height 67")

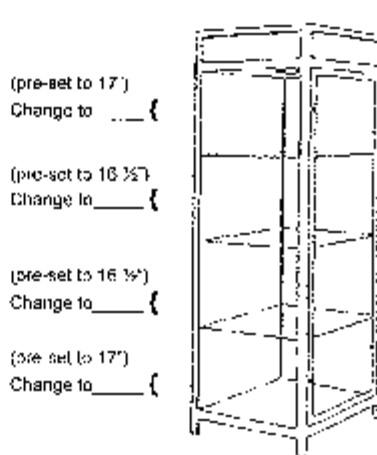

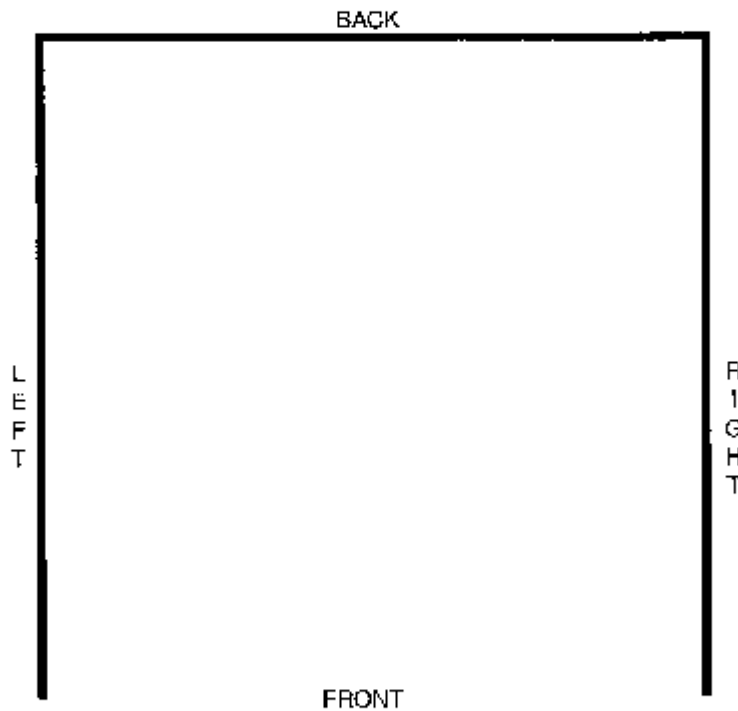
