Only badged persons will be allowed on the floor during set up and breakdown. Helpers must remain in your booth during set up. Anyone sharing a booth must sign a sharer's application. Sharers do **not** automatically receive exhibitor badges or buying privileges. **NOTE:** Trucker badges should be ordered in advance.
